Scholarship/Endowment Discussion

- There are 3 types of gifts scholarships, programs, and awards. Endowments exists in perpetuity. Whereas if it is annually funded, a budget could be created.
- A scholarship can specify the recipient type such as a Food Science undergraduate. Minimum endowment level for a scholarship is \$50,000. An annual scholarship minimum requirement is a 5 year pledge at 5% of the minimum endowment level (currently \$2500).
- An example of a program is supporting tutorial services. Minimum endowed program is \$25,000. Minimum annually funded program is a 5 year pledge of \$1250.
- An award is recognition for an achievement with a monetary amount. The minimum endowed award is \$20,000. The minimum for an annually funded award is a five year pledge of \$1000.
- Liz will follow up with Lauren Steinberg on whether we need to go through the development office and can we give more depending on funds in the budget.
- Some ideas: Long-Term endowment would be desired.
- Tie into corporate membership with the name on the endowment.
- We will make a decision at the summer meeting.

Pennsylvania Food Innovation Nework (Presentation by Susan Mayer)

- It is a public, private, and academic network to transfer knowledge and research to food companies and grow food business in PA.
- It is managed through Penn State Berks Campus.
- There was a grant that was funded to involve technology transfer with food companies. It was also be the industries voice to state government on future policy and expenditure decisions.

Title:ScholarshipsShort Description:Minimum endowment level \$50,000

General Scholarships are scholarships which may be designated for a particular campus, college, or group of recipients, such as those from a specific geographic area. The benefactor of these scholarships also may give his or her preference - **consistent with University policy** - concerning other criteria. In this manner, the benefactor can help to shape a scholarship that is tailored to his or her interests. For example, the scholarship could be designed to help students who are going through the same academic programs as did the benefactor or could be named for someone important in the benefactor's life. Such a scholarship can be established in perpetuity for a minimum of \$50,000.

Trustee Scholarships are established to provide financial assistance to undergraduate students. Such a scholarship can be established in perpetuity for a minimum of **\$50,000**.

Annual Scholarships are an option for a benefactor who may want to fund a scholarship on an annual basis in lieu of endowing the scholarship. The minimum amount required to annually fund a scholarship is five year pledge at 5% of the minimum endowment level (currently \$2,500). A benefactor may also choose to annually fund a scholarship during their lifetime while also choosing to endow the scholarship upon their death with some type of deferred gift (i.e. gift annuity, charitable remainder trust, bequest, etc). This gives the benefactor the opportunity to enjoy the benefits of their scholarship during their lifetime while having the peace of mind knowing that the scholarship will be established in perpetuity upon their death.

Title:Program Support/General EndowmentShort Description:Minimum endowment level of \$25,000

Program support endowments are designed to enhance the academic environment of our students and faculty, often merging the special interests of a donor with enrichment opportunities. Examples range from endowments supporting student tutorial services to undergraduate research and from faculty travel funds to professional development initiatives for students and faculty. Program endowments can be designated to a college, campus, department or program of a donor's choice.

- A program can be endowed with a minimum of \$25,000. However, please keep in mind that the amount of the initial gift depends on the nature of the program that is to be supported; practical minimums should be determined.
- A program can be annually funded with a five year pledge of \$1,250. Keep in mind the previously stated minimum requirements.

Title:AwardShort Description:Minimum endowment level of \$20,000

An award is recognition for achievement of a single specific nature. It may be for grades, for activities, or a combination of both grades and activities. For example, a benefactor could choose to endow an award that would be presented to the student with the highest grade-point average within a certain academic subject area. Students, faculty, or staff are inspired to attain higher goals than they would have attempted without the motivation such an award invites.

- An award can be endowed with a minimum of **\$20,000.**
- An award can be annually funded with a five year pledge of \$1,000
